Pine Bluff Park Rules & Regulations

The following rules and regulations are for the protection and benefit of all members and to ensure the safe and sanitary operation of the facilities. Members are requested to caution their children and guests to observe all rules and obey the pool staff, for any failure to comply with these rules shall be considered sufficient cause for cancellation of membership. Guest conduct is the responsibility of the admitting members.

Entering Pool Facility - Everyone must drive slowly and carefully in the parking area. Pine Bluff Pool, facilities and property are use at your own risk. Pine Bluff Park and Pool, Inc. assumes no liability for accidents or property loss. No intoxicated persons will be allowed entrance. No Smoking, No Alcoholic Beverages, and No Glass are allowed in the pool facility or at the entrance way of the facility. No abusive language is permitted. Only "on duty" staff are permitted in the office. Admission may be refused to anyone physically unfit to enter the pool. Admission may be refused to any member not paid in full. Members must sign their names and anyone's names that are with them. Guest fees will be due for anyone checking in that is not listed on the membership application or list. "Members" are considered any adults and their dependents living in their household, all others with members must pay guest fees. Children under age 14 must be accompanied by an adult or a responsible guardian, no exceptions!

Conduct, Safety, & Health Rules Pool Area Safety - No running, pushing, wrestling, or causing undue disturbance in or around the pool area. No diving in the shallow end of the pool. No rafts or pitching balls when the pool is crowded. No food or drinks permitted in the water.

Lifeguards - All members (adults and children) are to respect the lifeguards' decisions and the disciplinary actions for not abiding by the rules. It is up to the parent or guardian of the children to help their children to know the rules and to obey them. Depending on the severity of the problem, the lifeguards can choose to blow the whistle at them, make them sit out for a period of time, or make them leave the pool for the remainder of that day. If there is an ongoing disciplinary concern with a member, the board will have final authority to assess the appropriate disciplinary action, this may include termination of membership without refund.

Diving Board/Slide - Only one person is allowed at a time. You must wait until the water is clear of swimmers below before diving. Flotation devices are not allowed while jumping off the diving boards. Only one person is allowed at a time on ladders, diving boards and slide. The sitting position is the only acceptable position allowed on the slide. No flotation devices allowed on the slide. (Excludes "Water Wing Arm Floaties")

Baby Pool - Only children ages 6 and under are allowed in the baby pool. Those not potty-trained must wear swim diapers (available for sale at the pool office). Parents or Guardians must supervise the children in the baby pool and its surrounding area as lifeguards are not responsible for the baby pool area.

Swimming Ability - Never substitute the use of a floating device for swimming ability. If a lifeguard doubts the swimming ability of any person, they may request the person to demonstrate their ability before swimming in the deep end and using the diving boards.

Storm Policy - The pool will be vacated for 30 minutes for thunder &/or lightning. The details are posted at the pool facility.

Conduct in Pool - Never fake trouble or calls for help. Diving off someone's shoulders will not be permitted. No hanging or pulling on ropes. Do not block the ladders. No Frisbees are permitted in the pool at any time. No unnecessary conversation with "on duty" lifeguards. No cursing, abusive language or profanity is allowed at any time. Report any unsafe conditions or conduct to the lifeguards or pool manager.

Health Rules - No expectorating or blowing your nose in the pool. Admission in the pool may be denied due to intoxication, open sores, skin infections, nasal or ear discharges, or any evidence of a condition (at the discretion of the manager) that would jeopardize the health and/or safety of the members. No pets allowed in the pool facility.

Cleanup - Trash must be placed in the containers provided. Each member is responsible for cleaning up after themselves and their guests (spills, trash, etc.) Bathrooms should be kept clean at all times. Spills and food on the concrete deck need to be cleaned up immediately to prevent stains.

Chairs - No large lounge chairs can be stored at the pool due to limited storage space. Members are to only use their own chairs that should be clearly marked with their names and placed in the shelving unit provided for chair storage before leaving. Chairs are to be removed from the premises at the end of the season or they will be destroyed or donated. Please direct any questions or suggestions to the pool manager or any board member.
