- VI. Wendy will update the swim lesson manual and train the guards teaching the swimming lessons.
- VII. We will give semi-private pool party vouchers to up to five charities who ask for a silent auction donation.
- VIII. Advertising Sommer has the first mailers ready. Tina will help distribute to various post offices. Grottoes zip code was added to mailer list due to the pool at Grand Caverns being closed this year. Brochures are in the process of being made. Sarah Davis will get a list of local preschools and Clymore, Hugh K Cassell, Wilson,

and South River Elementary Schools and call to get information on dropping off brochures. Email promotions are going out as well as Facebook ads for next week's sale. This sale does have a limited number of available memberships at the discounted price.

- IX. Troy is working on a number of things to include the installation of new locks and security system. There is a list of things needed to be done at the pool on the google drive drop and keys are in the box on the door so board members can drop by to work at any time. Johnny has been repairing many electrical issues as well as working on many other projects around the pool. Call either of them if you have questions on what to do at the pool. Opening duties will be on list on the google drive.
- X. We need a Parkerfest Coordinator for scaled down version to include a bouncy house, hot dogs, insurance, face painting on May 18th. If no coordinator by April 1, no Parkerfest.
